- 2. All certificates and Grade / Mark sheets in support of your educational / professional qualifications at all levels.
- If the applicant is employed in Government / Semi Government organization and his / her application has not been forwarded through proper channel, a "No Objection Certificate" from his / her present employer to this effect.
- 4. Certificates issued by Competent Authority in support of **experience**, if any, indicating the nature of duties performed.
- 5. Certificates issued by the Competent Authority in support of SC/ST/OBC/PWD, if applicable.
- 6. Relevant certificates / documents in support of all claimed credentials in respect of essential / desirable requirements as per advertisement and as claimed by you in your application.
