  - (iii) One works each costing not less than the amount equal to 80% of the estimated

3.1 Average annual financial turnover:

> Average annual financial turnover on construction works should be at least 100% of the Estimated Cost during last 3 consecutive financial year ending 2018-19 duly signed by the Chattered accountant.

4.1 Financial solvency:

> Financial solvency certificate issued by the Scheduled Bank as per proforma given in technical bid document (Proforma-2C) for amount not below 40% of Estimated cost during current financial year.

- (ii) In case of partnership firm, certificate should include names of all partners as recorded with the Bank.
- 5.1 G.S.T registration:

Self attested copy of G.S.T registration certificate. The agency should submit the GSTR-3B return along with payment receipt for the month of October, 2020.

6.1 EPF registration:

Self attested copy of EPF registration certificate including paid challan for the month of October, 2020.

7.1 PAN No .:

Self attested copy of PAN card.

An Engineer (Civil), diploma with minimum five years experience in the required field or 8.1 B.E. (Civil Engg) must be engaged by the contractor (Whose certificate duly selfattested, one copy photo & an undertaking by the Engineer in original is to be enclosed with the technical bid failing which the tender will not be considered) to supervise the work. The Engineer engaged must be familiar with all the works specified in the contract & must be acquainted with CPWD specification, manual etc. The engagement of engineer is not mandatory for Contractor possessing technical qualification.
