3.1 Up to date Electrical Supervisory license (ESL) issued by the Licensing authority, Govt. of Assam appropriate to the nature of work.

4.1 Work Experience:

Experience of having successfully completed works during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three similar works costing not less than the amount equal to 40% of the estimated cost
Or (ii) Two similar works costing not less than the amount equal to 60% of the estimated cost.
Or (iii) One similar works costing not less than the amount equal to 80% of the estimated cost.

5.1 Average annual financial turnover:

Minimum year-wise Turn Over in rupees, during the last three years which should not be less than Rs. 92 lakh per year.

6.1 Financial solvency:

Financial solvency certificate issued by the scheduled Bank as per Performa given in technical bid document (Proforma-2C) for amount of Rs. 74 lakh during current financial year.


