



NOTICE INVITING TENDER

The Director, National Institute of Technology Silchar – 10, invites sealed item rate tender from experienced financially sound contractor/agency of appropriate class and category (Civil/Electrical works), registered with Central PWD, Assam PWD, MES, Railway, BSNL and nationally reputed firm only for the work detailed below:

The contractor / agency is to satisfy the following conditions. Failing which the tender is liable for rejection. Pre – qualification criteria of the agency (to be furnished along with technical bid document duly filled up).

1.1 Contractor's registration:

Self-attested up to date (renewed) contractors' Civil (SI No. 1 to 3) and Electrical (SI No.4) registration certificate of appropriate class and category. For electrical contractors' shall also be submit (a) valid electrical contract license and (b) valid electrical supervisory license issued by the competent authority.

2.1 Experience of having successfully completed similar nature of works during last 7 years ending last day of the month previous to the one in which applications are invited:

(i) Three works each costing not less than the amount equal to 40% of the estimated cost of work.

Or (ii) Two works each costing not less than the amount equal to 60% of the estimated cost of work.

Or (iii) One work each costing not less than the amount equal to 80% of the estimated cost of work.

Completion certificate for the similar work(s) should be in prescribed format given in Proforma-6 of the technical bid documents issued by the officer not below the rank of Executive Engineer of Govt. / Semi Govt. Department.

3.1 Average annual financial turnover:

Average annual financial turnover should be at least 30% of the Estimated Cost during last 3 consecutive financial year ending **2017-18**.

4.1 Financial solvency:

Financial solvency certificate issued by the Scheduled Bank as per proforma given in technical bid document (proforma-2C) for amount not below 40% of the Estimated cost during current financial year.

(i) Bankers certificate should be on letter head of the Bank in original address to the Director, NIT Silchar in sealed envelope.

(ii) In case of partnership firm certificate should include names of all partners as recorded with the Bank.

5.1 GST Registration: Self attested copy of GST registration certificate.

6.1 EPF registration: Self attested copy of EPF registration certificate including challan current for the year.

7.1 PAN No: Self attested copy of PAN card.

Tender documents are to be submitted in 3 (three) separate envelopes. 1st envelop should contain Earnest Money, 2nd envelope should contain pre-qualification (technical bid) duly filed up & signed along with relevant document as prescribed, and 3rd envelope should contain the price bid.

All 3 (three) envelopes are to be sealed in a single envelope, mentioning name of work, NIT No, closing date and time. The 3rd envelope containing price bid will be opened only for those contractors who are found technically qualified as per conditions of NIT.

Request for issue of tender bid document will be received up to 1:30 pm on **23/10/2017** and the bid document will be issued till **25/10/2017** up to 04:00 pm. The completed bid document will be allowed to drop in the tender box available at Estate Engineering Branch of the Institute up to 02:00 pm on **27/10/2017** and will be opened at 04.00 pm on same day. The price bid of the technically qualified agency will be opened on **31/10/2017** at 04.00 pm in presence of agencies or authorized persons thereof.


Earnest money (refundable) should be deposited in the shape of (i) Deposit at Call receipt of a scheduled Bank guaranteed by the Reserve Bank of India or (ii) Bankers cheque of a scheduled Bank or (iii) Fixed deposit (FDR) of a scheduled Bank in favour of "Director, National Institute of Technology Silchar-10.

Cost of tender paper (non-refundable) should be deposited in the shape of Demand Draft in favour of Director, NIT Silchar or cash to the deposited at Cashier, NIT Silchar.

Tender of any contractor not accompanied with proper earnest money and incomplete tender, non submission of requisite documents (self attested) under Sl. 1.1 to 7.1 of the NIT or in any form shall be summarily rejected.

If any, holidays / strike falls during the notified days, the process will be continued on next working day.
